#### 2 What are cookies?

#### 4 Categories of cookies?

- Essential cookies: Also termed strictly necessary cookies, these cookies are fundamental to website functionality and cannot be switched off without blocking features or compromising security of the site.
- **Functional cookies**: these are used to enhance your experience (e.g. remember settings) and are set with an expiry period of one year.
- Tracking and performance cookies: these cookies are not used on this site.
- Targeting and advertising cookies: these cookies are not used on this site
